Write that's not me in red ink.

You can file your own Petition in Removal; see Lone Star Steel Company v. Scott. You must express, that I am not that fiction on the warrant or information that was served upon me, if you was illegally charged with a crime, and I think by us doing this process, it would be the best approach to deal with our criminal justice system and for reform.

We have to express, to the government authorities, "I am one of the People and a living Soul. I am not a corporation, and I demand my remedy in the Court of the People in the County Court of record. I petition the Court to remove Case No. #### From admiralty court under contract law into county court, for the People under Common Law.

When do you stand in G-d Allah's Sovereign Kingdom? Because as a African American- Black Muslim I stand in

G-d Allah's Sovereign Kingdom. Refuse to give your slave name. To Waiver of Process, See Boaiers Law Dictionary, 8th Edition, See **Boyington vs. Chamberlain**, 38 place state of Texas 604; **Thompson vs McCorkie**, 136 place State of Indiana, 484 NE Reporter 813.

All crimes are commercial crimes (FRCP Rule 2, Title 28, 7th Amendment to the constitution, which preserves the right of the People to a common law venue).

The way these laws were designed the white elite; would say, "The fiction in which the case is styled is not Me. I am really Me, a living soul, one of the sovereign People of the several states united. I demand to move the case into my Venue where the People have remedied in common law".

A landmark case for establishing who the People are **Kemper vs. State**, 138 Southwest 1025 (issued in 1911), which says on page 1043, 33. One sovereign does not need to tell another sovereign that he is sovereign. The rule in place country region America is that the American people are the sovereigns.

We have a right to know, you have the right as a sovereign to control both sides of your life, the common law (private) and statutory (public). See **Baldaut vs. Nathan Russell**, 96 **Atlantic Recorder**, and page 96 (88 NJ law 303).

A fictitious plaintiff is a fraud upon the court, because it goes beyond his or her own code. Every accused man or woman should notice the court of that fraud and demand remedy. Especially Black people, who was made slaves and property to the white elites, as well as given their so-called slave masters names.

On the slave plantations, and/or as they are doing today, in modern times with their corrupt criminal justice system, convicts the fiction and the live

man/woman serves times in jail. The state creates the fraud, but a real, live man or woman must agree to it for it to be carried to execution.

That's not me - I'm not that thing (Slave-fiction or fraud)! You have a right to make dilatory pleas and point out their errors. That's not me, on that piece of paper. In fact, that's not YOU on that piece of paper. (Recall these instruments created by the government Trust-corporation, and it was identified by my slave name, most often spelled in upper case letters. It's also known as the Nom de Guerre, or war name! That Trust-corporation is called a Straw man and is a 'Front'. That's not really me! That's not my real name!

A discussion about the demands to give up our slave masters' names was taught to us in the Nation of Islam, and when members was given an X, like in Malcolm X, until he was given his - Islamic Muslim name. To be further discussed later.

REDEMPTION! A program that has been associated to a type of 'jubilee,' the definition of Redemption is the deliverance from the power of alien dominion and the enjoyment of the resultant freedom.

Alien dominion? Well 'Alien' means foreign or strange and dominion means 'country under a particular government. AMERICA.

Redemption could be called the program to 'deal' with this alien form of a foreign quasi-military bankrupt corporate government operating under the UCC, as it is being foisted upon you the people.

The word in the title "NAME" is all Caps for a reason. It is the Fiction or legal fiction (ACTOR) whose name sounds exactly like mine (idem sonans). See G-man at wtpcc@lycos.com

The government has attempt to make a corporation out of you, too, by writing my so-called slave masters' Christian appellation in all-capital letters which is a clear prejudice against you, according to Texas Rules of Civil Procedure (TCRP) Rule 52, Alleging a Corporation.

"Allegations that a corporation is incorporated shall be taken as Truth unless denied by affidavit of the adverse party, his agent or his attorney, whether such corporation is public or private and however created." Your name was similarly corrupted when a constructive trust was established as you volunteered into Social Security, making you a part of the national socialist democracy and assigning you an employee I.D. number (SSAN). TCRP Rules 53 and 54 affirm the notion that if someone alleges that you are a corporation and you do not deny it in a timely manner, you are an indeed a corporation for the commercial matter in question.

One method of obtaining control over the all-capital fiction is to file a UCC-1 financing statement with the Secretary of State. Another is to bring that fiction under your domain as private intellectual property through a copyright, which enjoys the protection of common law when made a part of the public record with the local county recorded. TRCP Rule 52 was cited in **Galleria Bank v. Southwest Properties**, 498 Southwest 2nd, page 5 as follows:

"The failure of an adverse party [i.e. you] to deny under oath the allegation that he is incorporated dispenses with the necessity of proof of the fact."

Your declaration of "That's not me!" needs to be made by affidavit when it is to become a part of an official record. Refer to **Dr. Pepper Company v. Crowe**, 621 SW 2nd 466, which held as follows:

"Plaintiff pled defendant as a corporation. Defendant did not deny by verified pleading, pursuant to FRCP 52 and 93 that he was not a corporation. Thus, such fact was established."

First, record a copyright of the ACTOR's name and then pursue discovery with the sender of the presentment: Inquire whether the sender is making a claim against your copyright and, if so, how they

propose to handle the cost of such a claim (one million dollars in United States silver coin per use per issuer). (The presumption is that the sender is using the ACTOR's name in an attempt to extract something from your estate.) Claims for unlawful use of the copyright full under common law and not under the commercial statutes regulating negotiable instruments and contracts, therefore silver may be demanded in any settlement, instead of federal reserve notes or credit instruments of the United States.

Texas penal Code Articles 1.03, 1.04 and 1.07 (and similar language in each of the other states' code) says that the only crime which may be committed by one of the People is a common crim.

Gain control of the all-capital letter ACTOR's name by means of a common law copyright and remove it from commerce so the state cannot use it against you. This is the highest form of title one can possess once the recorder's office attaches a deed number. With a copyright in hand, a man has returned control of his life to himself and out of the hands of the state. Anyone coming against the ACTOR after that point is required to post a bond equal to double the value of the copyright property before commencing action.

However, the name that is being recorded for copyright is NOT your so-called slave-masters' Christian name - it is the moniker of the alleged fiction, the corporation or ACTOR, whose name just happens to sound like yours. Furthermore, your papers are being submitted to the common law side of the recorder's office which recording takes precedence over statutory process. Be aware that a man can copyright ANY of the fruits of his labor, whether it be from his hands or his mind, and thereby protect those fruits for his own exclusive use by withdrawing them from commerce and the Public domain.

IMPORTANT: Use care in selecting your terms, "File" is a statutory term "Record" is a common law term. The copyright is private intellectual property "recorded for the public notice". You only have statutory privileges and immunities.

A change of venue motion [supported by his own affidavit] and the affidavit of three credible persons, residents of the county in which the case (suit) is pending.

PETITION REMOVAL: When filing your petition you must say:

"I am not that fiction on the warrant or information that was served upon me. I am one of the People and a living soul. I am not a corporation. I demand my remedy in the court of the People in the county court of record. I petition the court to remove Case No.### from admiralty court under contract law into the county for the People under common law."

Mandatory steps to taking back control of your legal life:

2. On receiving and presentment, respond automatically with that's not me,
3. Find the remedy in your own state statute or code to counter the action being brought against you and FILE THAT REMEDY in your own real name.

When you accept a piece of paper with your capitalized name and, whether you like it or not, you will be captured into a statutory venue to be treated like a corporation and manipulated. An Affidavit of Non-Payment, with your bill attached into the county record's office. You can add fuel to the fire by filing a criminal complaint charging deceptive trade practice through the fraudulent use of commercial paper and fraudulent commercial process.

You have used my copyright without my permission to extort some benefit or money or property from my personal estate and I am lodging a claim for damages. I have taken steps to protect my estate and you have used my copyright without my permission and you owe me one million silver dollars.

Make a sworn affidavit alleging crimes against the People - placed into the public record by one of the Sovereign People, A Sovereign to write an affidavit and declare "This crime occurred to me," and put it into the county record's office.

The so-called slave master's Christian name (title) given to me when I was born, was given to me by my mother and father without my consent. My mother was a descendent of Native American, and my father was a descendent of Africa Muslim, forced into slavery, given a so-called slave master's Christian name, and suffered from a Holocaust.

"Yours" and my argument to the judge FOR THE RECORD, 'that fiction listed on "your"; or mine paperwork is NOT Me!'" You can sentence that fiction to anything you please - if you think you have title to him. But, you do NOT have title to Me, so you cannot do anything to Me, and I do NOT give you permission to do anything accept dismiss the case and discharge all charges with prejudice!

Furthermore, there is evidence of fraud and collusion on the part of the prosecution who has brought an action in the name of a fictitious plaintiff. This is an equity count and you either move by contract or by title. I don't have any contract with you and I know for certain that you don't own me; I'm not your slave. I am a living soul. You may address me as Russell Tinsley. I am me, who live ill my body, and NOT a corporation or a fictitious creation of the state.

You are one of the sovereign People. You have a right to copyright your name. See **Baldauf vs. Nathan Russell, 96 Atlantic Recorder**, Page 96 (88 NJ law 303), every accused man should notice the court of that fraud and demand his remedy.

The ACTOR, being a fiction, has no capacity to speak, or write, or act, or pay fines, so serve time in jail. The system convicts the fiction and the live man; or woman serve time in jail! The state creates the fraud, but a real, live man; or woman must agree to it for it to be carried to execution.

The copyright is your private property and it is your right to get it recorded with the county recorder. Citing 5407 and 5408 of Revised Statutes of the United States, 1st session, 43rd Congress, 1873 - 1874, and Once you copyright the legal fiction and remove it from public domain, the use of that property without your permission will cast the user a price which you set in the public record when recording your copyright.

Our, mine and yours' criminal conviction / contract was made without my consent and lacking full disclosure that is willful, malicious and deceptive trade practice. The opposition assumes that you will not know the truth, will traverse to that fiction and will automatically be captured into their Venue - and be the means to creating additional revenue to fund the state machine.

We must file a petition for an identity hearing-in-advance-to clarify which party the opposition really want to appear in court, and attaching a copy of your recorded copyright when you file your petition.

When, where and how, if taken into custody, to appear in court, be prepared to contest jurisdiction when asked to give your name, and upon receiving the warrant, insist without hesitation, "That's not me!" "I am me." "I own exclusive title to the ACTOR being charged in the action". What commercial purpose do you have for that ACTOR and how do you propose to pay for the privilege? The fee is one million United States silver dollars per use, per issuer. Send a bill to anyone infringing on your copyright without permission. Wait 30 days to receive payment and then record Having ourselves being used as a fictitious plaintiff that - then has no foundation in either the constitution or the statutes, and do not waive process - then they have NO Jurisdiction over you. (See "indemnifying party" and "accommodating party" in the Uniform Commercial Code).

The legal fiction is an ACTOR, a corporation, an employee, a straw man -it's all of those things - but, it's not you!

File a petition for an identity hearing-in-advance to clarify which party the opposition really wants to appear in court, attaching a copy of your recorded copyright when you file your petition.

Get a BAR card and obtain standing with the court, and/or Stay out of their courts, because, "That's not me!" If taken into custody "contest jurisdiction" when ask to give your name. "I am me." I'm not the JOHN DOE you have on your paper work. I am me. Do you have a claim against me? Do you know anyone who has a claim against me? They can't have a claim against you, because they don't have title to you, like they do have title to the ACTOR unless you have recorded your copyright.

You say, "I claim the bond because I own the property as evidence by title to a deed recorded in the county."

NOTES: About your signature UCC1-207 /UCC-1-308.

To File a UCC-1 and send the chargeback to the Treasury, Affidavits and complete CAFV process, and Visit your state's Risk management Office. Filing of the Lien is done into that jurisdictions' Secretary of State/UCC Department.

Subject matter jurisdiction (SMJ): You are telling the court they don't have jurisdiction over the subject matter to hear the case. Use a notary address. Example: Russell Tinsley Non-domestic c/o sign your autograph in red ink.

Negative Averment: "I am not a fictional limited entity!" I am a nature born slave of the Creator, Allah. (A fictional limited liability entity, otherwise known as a corporation), and I chose to use the Creator's Arabic name, that He instructs Prophet Muhammad to tell the human being (Man and womankind), because I believe it carries the weight of truth.

Another example: "The fictitious name TINSLEY, RUSSELL a straw man, or Dummy Corporation created by the government corporation without my knowledge or intent of the natural person Russell Tinsley, only exists under the color of law and claiming only to be legally incorporated for the purpose of commerce and exercising the powers and functions of a corporation without actual lawful authority to do so, but strictly for the benefit of the government corporation and its commerce".

The government corporation shows the capital letter spelling of the SECURED PARTY name when they created the "fictitious named" corporation, due to the need of a specific name required for each separate legal entity's identification. Therefore, when a corporation is constructed, a name is always given to it, or supposing to be actually given, will attached to it by implication, and by that name is capable of being changed (by competent authority) without affecting the identity or capacity of the corporation. See Wharton on Corporations. See also Black's Law Dictionary, 6th ed., "Dummy Corporation" means RUSSELL TINSLEY, an artificial person or legal entity created by or under the authority of the laws of a state or nation, composed, in some rare instances of a single person (Such as the SECURED PARTY).

"The corporation is distinct from the (individual) or individuals who comprise it". Such entity subsists as a body politic under a special denomination, which is regarded in law as having a personality and distinct from that of its several members". **See U.S. v. Trinidad Coal Co.**, 137 U.S. 160, 11 S.Ct. 57, 34 L.Ed. 640.

Like Brother Malcolm X, as he represented the Nation of Islam, and all that I claim is that I have strived to the best of my ability to present spiritual insight, through the eyes of those who support him and respect our history with the Nation of Islam, and to continue to present the work of Imam W. Deen Mohammed, which I know will be beneficial for me and for the Muslims' Community in the like of this world and in the Hereafter. Insha Allah.

If I have succeeded, my father's leadership of the largest indigenous group of Muslims, then that was the (AIM) of the Community in Association with Imam W.D. Mohammed - The Mosque Cares/WDM Ministry and all bounty and grace belong to Allah. If I have not done so, then it is sufficient for me that I intended well and strived to the utmost of my ability to attain that (AIM) "Associate of Imam Mohammed, and deeds are (judge) solely according to my intentions.

This is based upon the Hadith of "Umar Ibn Al-Khattab, who said: 'The Messenger of Allah said: "Deeds are purely in accordance with intention"' and Narrated by Al-Bukhari (No.1), Muslim (No. 155/1907) and others.

O Allah! Make all of my deeds righteous and purely and sincerely for the sake of Allah, succeeding Imam W.D. Mohammed's leadership, for the sake of Allah, and do not make association of any partners in Allah. . Amen.

For Imam Mohammed's family, I'll be looking forward for your approval and views to my position, as well as to discuss our concerns for the Muslims and in a meeting to choose a successor, and / or Spokesman for WDM Ministry/The Mosque Cares.

In my closing, with this chapter, I would like to remind the family and Associates of Imam Mohammed,

because of my relationship, was so close to my father, the Chicago Police authority and the United States Federal Bureau of Investigation (FBI), and other government related bodies, they began their arrangements of plots, a long time ago against us, and I remember their plot against Minister Louis Farrakhan, who was the Minister in New York City (Harlem), and when he was the national representative for the Honorable Elijah Muhammad and the Nation of Islam.

In October 1974, before the year of the passing of the Hon. Elijah Muhammad, and before my father (Wallace) Imam W. D. Mohammed was unanimously voted in, to lead his father's community "The Nation of Islam". I was personally approached by federal agents, to become one of their informants, to be sent ahead of Imam W. D. Mohammed, in the Nation of Islam, and at least to report on all of the Minister Louis Farrakhan's dealings with any illegally activities, in which I refused, because not only was Minister Farrakhan was my brother, but it was forbidden for a Muslim to spy on one another in Islam. Read Qur'an Surah 49: 12.

I learned then at an early young age, and understood, there were enemies among the ranks in the Nation of Islam, to bring down our leadership and destroy the Nation of Islam. Nonetheless, because of my refusal to become an informant, I have been attacked, arrested on bogus charges by police from around the country, who either tried to kill me; and/or sent me to jail and prison to serve time for crimes that I did not committed, time after time.

They wanted to destroy my representation and assassinate my good character, by wrongfully labeling me as a convict, s-offender or criminal, this targeted abusive behavior continues up unto this present day, while I'm still being held incarcerated, and even under civil commitment.

Sister Amatullah Um'rani, MSW contributing writer, did a article March 13, 2020, in the Muslim Journal, entitle: "COINTEPRO A PART OF BLACK HISTORY" that I would like to recommend for you to review on her account to my situation, and a conversation for #BLACK LIVES MATTER.

She wrote: "There were enemies seeking to destroy the Lost Found Nation of Islam in the West (NOI) and other Black self-advancement groups from their early days.

In some cases, attacks came from specific persons working within the United States Federal Bureau of Investigation (FBI) and other government-related bodies.

NOI Founder, Master Fard was arrested and forced by police to leave Detroit on 5/26/1933 and was not publicly identified after that time.

According to documents unclassified in 1980, the FBI would spend decades searching for him, in connection with encouraging allegiance to the NOI over the U.S. government in his teachings from 1930-33 (372 pages, Wallace D. Fard, <https://vault.fbi.gov>)

Subsequently, Hon. Elijah Muhammad (HEM) and members refused to register for military service, as the U.S. entered World War II.

There were ongoing suspicions of their friendships or sympathies with Japanese, who were alleged enemies to the U.S.

"Confidential informants" were sent into the NOI as members, and at least one advanced to a high and trusted position of authority.

They made detailed reports on meetings, including a number of attendees and what was taught or discussed.

It was FBI activities that resulted in the 05/08/1942 arrest and questioning on "sedition; Selective Service" of Hon. Elijah Muhammad (alias Ghulam Bogans).

He was taken into custody again, along with others on 9/20/42.

From a 12/18/42 FBI report, approximately 65 were arrested and "large volumes of records and literature were confiscated."

HEM's response, recorded from questioning, reflected that he was very open about the teachings regarding not fighting in the war, and about his life, in general.

The FBI documented activities against every effective Black self-help and political group, the earliest of note being the Universal Negro Improvement Association and African Communities League (UNIA) under Hon. Marcus M. Garvey.

From Garvey to NOI to Malcolm to Dr. King to Fred Hampton and other Black Panthers, there were FBI agents who deceitfully made their ways into the innermost circles of trust or leadership to provide access and devise strategies to kill individuals and/or movements.

Blacks were not the only ones targeted, but there were certainly many, as compared to their percentage in the population.

In 1956, the process became codified, formalized, given a name - Counterintelligence Program and a nickname Cointelpro.

There was a specific goal, along with the strategies to reach it: "...expose, disrupt, misdirect, discredit, or otherwise neutralize the activities..." to prevent the "rise of a messiah..." who could unite large numbers.

Especially dangerous, in their eyes were those who taught and sought nationalism, or looking upon Black people around the world as brothers.

It was only as of the result of a break-in of an FBI office in tiny Media, PA, 3/08/1971 that some of the extents of Cointelpro's abuses became known.

The burglars only revealed their identities five years ago.

As the result of stolen documents being sent to, and published by some major newspapers, Cointelpro was officially closed, but not before murders, incarcerations, discrediting, and financial injury to so many great Black activists.

Meanwhile, activities continued. Informants remained in place. More recently, since 2014, BLACK LIVES MATTER movement received negative attention from some in government and others.

Cointelpro formally experience a type of rebirth in 2017 when an 8/03 FBI report unveiled the new term and category, alone with eight others, to be targeted by the FBI.

It was "Black Identity Extremists". It was alleged that responses to murders of African Americans by police would likely result in more activity, some directed toward police.

Just as the Black Panther Party for self Defense and the NOI during the 1960s and all Muslims after

"9/11" were wrongly labeled as threats or enemies, the behavior continues, and results in great danger to the citizenry:

1. The majority come to support or accept various types of abuses, incarcerations, and even murder of the targeted.
2. Tax money and resources are wasted.
3. Real threats can be more easily ignored.

FBI may have done some good in tracking real bank robbers, kidnappers, and other serious criminals, but agents have initiated and encouraged persons to participate in activities they would not have, on their own. While the entrapped go to prison or maybe killed, the provocateurs are allowed freedom.

Today's FBI and other such entities as National Security Administration (NSA) no longer have to send in spies or install wiretaps; they simply have to turn on your phone or tablet microphone.

Gaining information on how to protect is not the same as invading privacy and using "security" as an excuse to abuse liberties.

Some of the actions via Cointelpro can only be considered evil, as defined by Persons of Faith: when you could kill someone for simply trying to make life better for their person, which, in turn, makes it better for all!

On the other hand, the FBI that had sought to destroy later sought to help resolve murders of some civil and human rights activists. This shows the importance of the leadership of these agencies.

The President and the U.S. Congress members have very important roles in nominating and putting in place persons who will protect the rights and safety of the

citizens, to the best of their abilities. The local government has their roles, also.

We have allowed the concept of government to become too abstract: Instead of saying who, specifically, introduced or voted for a bill, who made a court decision, there is the tendency to say "the government..." or this government.

This takes the attention of the ones who are really responsible or even to blame.

Criticisms that rightfully belong to specific individuals or groups of them who have agendas, not "of, by, or for the people" are given to the very institution established to protect the citizenry.

Persons who kill or injure the innocent are enemies of the righteous - not for us to try to destroy physically, but to work against their plans.

When Allah, in al Qur'an, tells us that Satan is the enemy of the human, it is not to cause fear, but awareness.

Awareness of big enemies can increase our faith, as we see that so many persons and situations are potentially bigger, scarier, and more dangerous than we. But we don't accept to live in fear. We feel empowered when we move upon our obligation to act whenever and wherever we have the awareness and the use our abilities to make the government and community better".

This resemblance will be high population density, poor education, lack of political power and little economic or cultural strength. It is no accident that Black men (African American) is represented within the prisoner population by a highly disproportionate percentage.

One will also find that my community (African American Community) represents the highest rate of unemployment and the lowest rate of economic stability within the confines of America, to even be wrongfully convicted of a crime, in which they were innocent; or as in a sex offense would face the consequences of indefinite civil commitment that's used to hold criminals the state considers sexually violent predators.

My Black American Street Life experience affirmed my status as one of the brightest hustlers, and a Muslim, but with talent working in the entertainment industry. Currently Russell (Mac-T) Tinsley (Bunia Muhammad) is a CEO Chief Executive Officer of The Playza Club Records Co., and my own Entertainment Network and is writing my highly anticipated bio movie script.
